STAGE 1 – Initial Assessment



1. Candidate completes EBA application form for the desired qualification



2. Candidate gathers all evidence in support of their RPL application



3. Candidate gathers all identification documents



5. Candidate completes declaration document



4. Candidate certified all gathered evidence and identification documents



6. Candidate pays initial assessment fee



7. Candidate uploads completed EBA application form, all certified evidence and identification documents, and declaration document to the EBA portal



8. Qualified assessor reviews all uploaded documentation on the EBA portal and advise outcome within 20 business days

If assessor requires further evidence candidates can receive additional gap training AND/OR gather further evidence (Further evidence requests must be supplied within 28 calendar days of the request)

STAGE 2 – Final Assessment



1. Candidate pays final assessment fee



2. A booking is made for the candidate to undertake a technical interview



3. Candidate undertakes a technical interview



4. Assessor notifies candidate of the technical interview outcome within 10 business day



5. Your Future Career

If candidates are unsuccessful in the technical interview, they will receive a Statement of Attainment that lists the competencies the candidates have successfully achieved. (Candidates can appeal the assessment outcome within 7 days of the notification of the outcome)

Reassessment against the same qualification is offered to the candidate within 12 months of the first assessment being completed either through verification of on-the-job training or undertaking additional gap training (Reassessment fee applies)

The AQF is the national policy for regulated qualifications in Australian Education and training. Delivered through the Australian Government Department of Education, Skills and Employment in consultation with the states and territories, it incorporates the qualifications from each education and training sector (schools, vocational and higher education) into a single comprehensive national qualifications framework.

One of the key objectives of the AQF is to facilitate pathways to, and through, formal qualifications. It also complements national regulatory and quality assurance arrangements for education and training. The AQF is split into 10 levels, ranging from certificate 1, all the way through to Doctoral degree, with higher education awards including levels 5-10. There are two main national regulating bodies for education and training in Australia. These include the Australian Skills Quality Authority (ASQA) for vocational education and training, and the Tertiary Education Quality and Standards Agency for higher education where each have regulatory responsibilities according to the AQF levels.

AQF Level 3: Certificate III	Regulatory Responsibility: ASQA
AQF Level 4: Certificate IV	Regulatory Responsibility: ASQA
AQF Level 5: Diploma	Regulatory Responsibility: TEQSA/ASQA
AQF Level 6: Advanced Diploma, Associate Degree	Regulatory Responsibility: TEQSA/ASQA
AQF Level 7: Bachelor Degree	Regulatory Responsibility: TEQSA
AQF Level 8: Bachelor Honours Degree, Graduate Certificate, Graduate Diploma	Regulatory Responsibility: TEQSA
AQF Level 9: Masters Degree (Extended, Coursework, Research)	Regulatory Responsibility: TEQSA
AQF Level 10: Doctoral Degree, Higher Doctoral Degree	Regulatory Responsibility: TEQSA

AUSTRALIAN QUALIFICATION



As part of WAMC s Evidence Based Accreditation (EBA) program, candidates will first:

Step 1. Candidates will go through an initial assessment where their gathered evidence is assessed based on their desired qualification. This process is carried out by WAMC approved and certified Trainers.

Step 2. If approved, Candidates will obtain an industry recognized certificate. The candidate will then go through a final assessment as part of their Recognition of Prior Learning (RPL) application with an Australian Registered Training Organization (RTO).

Step 3. If Successful, candidates will then obtain an Australian Government recognized qualification from the RTO.

Australian Qualifications Issuing Authority:

All RTO's approved by the Australian Skills Quality Authority (ASQA) and work under the Australian Qualifications Framework (AQF) which is the national policy for regulated qualifications in Australian education and training. It incorporates the qualifications from each education and training sector into a single comprehensive national qualifications framework. Australian qualifications issued through an approved RTO are recognized by international employers and education institutions around the world. Because of the AQF, and ASQA it is also easier for overseas governments to recognize Australian qualifications.
